

CHANGE RECORD (2021)

The modifications set forth in this change record reflect updates made to the HTS after the 2021 Preliminary HTS, published January 1, 2021. Please note that the Change Record does not include endnotes or minor nonsubstantive adjustments to the format of any line. Nor does it show extensions of exclusions from the additional China tariffs, which are indicated by Compiler's Note in U.S. note 20 subdivisions. The following chapters have been reposted since the posting of the 2021 Preliminary HTS:

PRELIMINARY CHANGE RECORD (2021)

This change record sets forth all of the changes to the HTSA which have become effective on January 1, 2021, as well as all changes since the last printed edition of the HTS (the basic edition for 2020 with changes from online revisions 1 through 28 reflected). The table below also omits nonsubstantive adjustments to the format of any page. All tariff chapters are being reposted for this basic edition of 2020; the noncumulative change records of each online revision (available in the archive) list chapters reposted for each revision. Due to the record number of online revisions published this year, an additional column “Edition” has been added indicating the revision in which each change record entry was published.

Compiler’s notes have been added in provisions presenting errors or requiring clarification; for example, such notes reflect the extension of specific exclusions from the additional duties on products of China and the expiration of other exclusions.
